The 27<sup>th</sup> Annual General Meeting of the Company was convened and duly held on Saturday, August 10, 2019 at 11:30 A.M. at Auditorium ISKCON Complex, Hare Krishna Hill, Sant Nagar, Main Road, East of Kailash, New Delhi -110065.

Mr. Sunil Agarwal, Managing Director of the Company, chaired the meeting. The requisite quorum being present, the Chairman called the meeting in order and introduced the Board Members who were present in the meeting.

The Chairman informed that:

- As per the provisions of Section 108 of the Companies Act, 2013 read with rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time and Regulation 44 of SEBI (Listing Obligations and Disclosures Requirements) Regulations 2015, the Company has provided to the members the facility to cast their votes electronically in respect of all the businesses mentioned in the Notice.
- The remote E-voting facility was kept open for a period of 3 (three) days i.e Wednesday, August 7, 2019 (9:00 am) to Friday, August 9, 2019 (5:00 pm).
- The Company has also provided facility for voting through ballot papers to facilitate voting by those Members who were present at the AGM, either personally or by proxy and who has not cast their vote earlier through remote e-voting on all the resolutions as set out in the Notice of AGM.
- The Board of Directors has appointed Satish Jadon & Associates, Company Secretaries, as the Scrutinizer to scrutinize the remote e-voting process and for conducting the poll by way of Ballot paper in a fair and transparent manner.

The following business as stated in the Notice of 27<sup>th</sup> Annual General Meeting of the Company dated May 17, 2019 were transacted at the meeting:

## **Ordinary Business:**

- To adopt the Standalone and Consolidated Audited Financial Statements of the Company for the 1. year ended March 31, 2019 and the Reports of the Board of Directors and Auditors thereon.
- To appointment Mr. Anoop Krishna (DIN: 08068261), Director of the Company, who retires by 2. rotation and being eligible, offer himself for reappointment.
